 - Schools**
Purchases by a school with its principal campus in this State which is approved by the State of West Virginia to award degrees and which is exempt from federal and state income taxes under section 501(c)(3) of the Internal Revenue Code. WV Code 11-15-9(i)
 - Churches**
Purchases of services, equipment, supplies, food for meals and materials directly used or consumed by churches which make no charge whatsoever for the services they render. The purchase must be paid for directly out of the church treasury. WV Code 11-15-9(e)
- Sales Of Certain Specific Services**
 - Purchases of electronic data processing services and related software but not data processing equipment, materials and supplies. WV Code 11-15-9(z)
 - Purchases of services by one corporation from another corporation but only when both corporations are members of the same controlled group. WV Code 11-15-9(cc)

I understand that this certificate may not be used to make tax free purchases of items or services which are not for an exempt purpose and that I will pay the sales or use tax on tangible personal property or services purchased pursuant to this certificate and subsequently used or consumed in a taxable manner.
